

1. The applicant may be required to submit an undertaking that he/she is not in regular/part time employment anywhere and is not disqualified to take up the assignment if selected.
2. The candidate is required to carry all documents in original in support of his/her eligibility like proof of separation from the job/superannuation/proof of voluntary retirement at the time of interview.

#### **E- DETAILED TERMS & CONDITIONS**

##### **1. Remuneration:-**

- (a) Selected Candidates shall be paid an amount equivalent to their last drawn salary (Basic+DA as per LPC) from PSU/Govt. department where candidate had been employed minus current pension (if applicable) as per actual subject to maximum ceiling of Rs 2.00 lacs (Rs Two Lakh Only). Candidates are requested to submit the proof of last drawn salary from Govt. department/PSU and the Pension being drawn.


Selected Candidates shall not be eligible for any other pay over and above the remuneration as mentioned in 1 (a). The monthly consolidated fee as above will normally be paid by 7<sup>th</sup> of next month after deduction of applicable taxes.

##### **(b) Term of engagement:-**

- (a) The engagement will purely be on contractual basis for a period of one year from the date of joining, extendable by one year, at the discretion of the employer. Unless and until there is written communication for extending the above period, the contract shall automatically be treated as terminated on the expiry of one year period.

##### **(b) Termination of Contract:**

- (i) During the period of engagement, either party shall be at liberty to terminate this contract by giving one month's notice or one month's salary in lieu thereof;
- (ii) Due to an act of misconduct, omission or commission on part of candidates, PTCUL can terminate services with immediate effect without any notice period or any fee in lieu thereof and
- (iii) In case of violation of any of the terms of engagement by the selected candidate, PTCUL can terminate services with immediate effect without any notice period or any fee in lieu thereof;



**(c) JOB PROFILE: WORK MAY INCLUDE (BUT WOULD NOT BE LIMITED TO ) THE FOLLOWING:**

- (i) Inspection of PTCUL existing and proposed project and operation sites
- (ii) Identifying specific issues requiring action and detailing the remedial action required to be taken
- (iii) Carrying out preliminary survey of sites for transmission substations and lines as per requirement.
- (iv) Joint inspection/ survey with PTCUL representatives/ contractors.
- (v) Preparation, reviewing and apprising of environment related documentations, statements, reports data etc. obtaining environmental and forest clearances/NOCs etc.
- (vi) To obtain update and maintain, permits and standard operating procedures in relation to environmental, health and safety management.
- (vii) Technical support for environmental remediation projects and for legal actions including preparation of documents.
- (viii) Coordination & liaison with different agencies e.g., CWC, MoEF&CC, Pollution Control Board, concerned departments of State & Central Government etc.
- (ix) Providing implementation support to operations related to environmental compliance policies and project-specific environmental requirements.
- (x) Preparation and successful implementation of project environmental assessment instruments/documentation, including terms of reference for the preparation of environmental instruments, such as environmental impact/risk assessment, environmental management plans, environmental management frameworks.
- (xi) Preparation of information and reports as desired by the management.
- (xii) Presenting reports and findings of the specific task assigned before the representatives of the management.


**(d) Place of Posting:**

Initial place of posting will be at Dehradun. However, as per requirement it shall be required to visit existing substations, new projects, proposed sites or other locations of PTCUL.

**(e) Office Timings:**

Selected Candidates will observe normal office timing of PTCUL (10.00 to 17.00 Hrs) and will be entitled to weekly offs and Holidays as applicable in PTCUL. In case it is required to attend the office or assignments on Holidays/weekly offs or beyond normal working hours on working days due to exigencies, candidate will not be entitled to any compensation, whether monetary or otherwise in lieu thereof.

**(k) SUPERANNUATION BENEFITS:**


Selected candidates will not be entitled to any superannuation/terminal benefits with respect to services rendered during the period of contract.
